What is the malpractice insurance fee?

While the Dual Enrollment program covers all tuition, mandatory fees, and textbook costs, the malpractice insurance fee is a course related fee for programs that include a clinical or live work component. Students enrolled in these programs will be working directly with patients or clients and, like in any real-world setting, accidents can happen. Malpractice insurance is in place to protect Central Georgia Technical College, our instructors, and our students in the event that an accident occurs.

What programs require the fee?

The malpractice insurance fee is required for the barbering, cosmetology, phlebotomy, and nurse aide programs.

How much is the fee?

The malpractice insurance fee is \$11.50.

How can I pay the fee?

Please note that our instructors cannot accept payments for fees. You can pay the fee with cash, check, money order, credit card, and/or debit card (Visa and MasterCard):

- In person at the cashier window on the Warner Robins, Macon, or Milledgeville campus
- Online, using BannerWeb, with a credit card, debit card, or check
