# **Memorandum of Understanding**

This Memorandum of Understanding (MOU) intends to establish cooperation and collaboration between both parties for the promotion of international education, global student and faculty exchange, cross-cultural learning, and internationalization which aim to maximize opportunities for students and staff while being able to demonstrate shared commitment throughout the terms of the agreement to recognized standards of quality assurance for both institutions.

This MOU sets out the basis on which the parties will work together. Generally, each institution shall seek to promote:

- a. Student and staff mobility and exchange between the two institutions.
- b. Exchange of ideas on best practices for international education, program/content development, continuing education, and non-credit training.
- c. Development of study abroad opportunities in appropriate programs
- d. Other forms of cooperation and collaboration as the two institutions may jointly arrange.

All parties have agreed to enter into an agreement based on the following terms.

#### AGREED TERMS:

## Student and staff mobility and exchange:

- 1. CGTC and ZBC will help develop avenues of student and faculty mobility and exchange in a variety of disciplines including, but not limited to, Healthcare, Early Childhood Care and Education, Cybersecurity, and Aviation Maintenance.
- 2. CGTC will accept students and staff for short-term programs in addition to full 16-week academic semesters in approved academic programs or non-credit training opportunities.
- 3. ZBC will accept students and staff for short-term programs in addition to full 20-week academic semesters in approved academic programs or non-credit opportunities.
- 4. CGTC and ZBC will engage in virtual academic exchanges and learning opportunities to increase internationalization at both institutions.

Exchange of ideas on best practices for international education, program development, continuing education, and non-credit training.

1. CGTC will explore the opportunity to work with ZBC to support the capacity for professional development and international learning opportunities for innovation and program development, particularly in areas that each respective institution does not currently offer.

# Development of study abroad opportunities in appropriate programs

 CGTC and ZBC will work collaboratively on sending and hosting students for faculty-led, short-term study abroad programs.

# Other forms of cooperation and collaboration as the two may jointly arrange.

1. Both institutions will continue to explore opportunities for future collaboration as appropriate.

### PROMOTION AND FEEDBACK:

- 1. Both institutions agree to promote opportunities for continuing education, program development, mobility, study abroad as it pertains to the terms of this agreement.
- 2. Each institution will share feedback from students, faculty, and staff about experiences, and maintain a continuous dialogue supportive of student success and program sustainability.
