- Parents are unwilling to provide information on the FAFSA
- Parents do not claim the student as a dependent for income tax purposes
- Student has been “on their own” for several years
- Student does not communicate with parents
- Student was previously considered independent for the purpose of receiving financial aid but does not meet the current definition for 2022-2023.

Circumstances for Independent Status

- **Unusual Circumstances** - Situation meets none of the criteria below. Yes, Attach explanation and documentation No
- **Ward of the Court** - At any time, since you turned 13, were both your parents deceased, were you in foster care or were you a dependent or ward of the court. Yes, Attach statement and court documentation No
- **Emancipated Minor** - Determined by a court in your state of legal residence. Yes, Attach statement and court documentation No

Criteria for independence

For the 2022–2023 year, a student who meets any of the following criteria from HEA Sec. 480(d) is independent;

- was born before January 1, 1999
- is married as of the date he applies
- will be a graduate or professional student at the start of the award year
- is currently serving on active duty for purposes other than training
- is a veteran of the U.S. Armed Forces
- has children or has dependents other than a spouse
- was an orphan, foster child, or ward/dependent of the court at any time since the age of 13
- is an emancipated minor or in legal guardianship or was when he reached the age of majority in his state
- was determined at any time since July 1, 2021, to be an unaccompanied youth who was homeless or self-supporting and at risk of being homeless by an appropriate agency.
