# Academic Affairs Update CGTC Board of Directors Meeting

#### Agribusiness

CGTC enrolled 8 students spring semester in its new Sustainable Small Farm and Agriculture Technician TCC, 7 of whom are veterans. This program is being offered as part of the Ag Vets to Success project to offer handsin training in production, management, and marketing of small-scale food production in collaboration with AG Vets, Inc. (Comfort Farms) and Fort Valley State University.

#### **Engineering Technology**

The first dual enrollment HCCA student was placed into a paid internship with Gilmer Packaging for spring semester. Upon successful completion of the internship in May, this student will complete the Engineering Essentials TCC piloted this academic year. Plans are underway to offer this program to Bibb County students through Hutchings College and Career Academy next school year. Course credits from this program can be applied toward CGTC's AAS degree in Engineering Technology.

Engineering Technology program chair Joe Rossi has also been working on an AAS-BS articulation agreement with Georgia Southern.

#### Nursing

On January 13, CGTC Nursing faculty and students provided assistance in administering over 600 COVID-19 vaccines to the public at Taylor Regional Hospital in Hawkinsville. The RN students began their spring semester just four days prior to assisting with registration and screening, administering the vaccine, and monitoring citizens of Pulaski and surrounding counties after the vaccine. Additionally, CGTC healthcare faculty and eligible students are available to assist healthcare partners with future vaccination administration as needed.

#### **Enrollment and Registration**

- A comparison of <u>net</u> registrants for Spring 2020 and Spring 2021 is shown in the chart below as of February 5.
- The College is still enrolling students for Spring S2 students, DOC and HS DE students
  - S2 **2021** total enrollees = 484 students (as of February 5, 2021)
  - Compared to S2 **2019** total enrollees = 476
  - S2 Net Registration currently up by 1.6%

#### Admissions and Recruitment

- Enrollment processing for Spring Semester Session 2 is ongoing; Classes begin March 4.
- Participating in recruitment activities, mostly virtual, with local high schools and civic organizations.

### **Financial Aid**

- Working to develop process for distribution of CARES 2 student funds
  - o The College has a second round of \$2.5+ million to disburse to students for emergency relief funds
  - All student funds, less \$17,844, has been disbursed for CARES 1 funding
  - The College has submitted the HEERF/CARES annual report by the Feb. 1 deadline to the Department of Education.
  - The quarterly update report can be viewed online on the Colleges website; the most recent update is as of Jan. 10, 2021; the next update is due in April 2021.

#### **Career Services**
