**Program Description:** The Diesel Equipment Fundamentals certificate program is designed to introduce knowledge and skills to be successful in performing preventative maintenance and repair on diesel engines and equipment. Topics include an overview of diesel powered vehicles, safety, tools and equipment, basic welding skills, electrical and electronic systems, and drive train systems on medium and heavy duty trucks.

**Statement of Need for Program in the Service Area:** This is an institutionally-developed TCC and is an embedded program in the Diesel Equipment Technology diploma. This program was developed at the request of an industry partner for dual enrollment with Hutchings College & Career Academy.



### **Survey Update:**


- 118 students completed the AY 2020 Graduate Survey between <u>November 1, 2019 and January</u> <u>31, 2020</u>. 74 students requested additional assistance in at least one of the following areas: Admissions, Career Services, Registrar, and/or Alumni Network. The list of students was shared with the respective department for contact. The survey is on-going.
- 979 students responded to the AY2020 CGTC Academic Resources Usage & Satisfaction Survey, an increase of 862 responses from the prior year response count of 117. Students were asked to provide feedback on academic resources such as the Library and the Academic Success Center (ASC). The survey was open from January 29, 2020, to February 21, 2020. Final results were shared with the Director of Library and Academic Support Services for review. When asked which of the following academic resources they use and/or knew how to access, students answered:

### Multiple Measures Pilot for ECON 1101 for Houston County Dual Enrolled Students

• The Office of Institutional Effectiveness is coordinating the research for the multiple measures pilot program for the dual enrolled ECON 1101 course agreement with Houston County Board of Education beginning August 2020. A Research Plan has been developed to collect data during the pilot and will include: PSAT Scores, HOPE GPA, Highest Math Course Taken at High School and Grade Received, ACCUPLACER Next Gen QAS Scores, Midterm Exam Grades, Final Exam Grades, Final Class Grade, and Student Learning Outcome Data. A report of results from the pilot will be provided in May 2021, after conclusion of the pilot.

### **Professional Development**

Titan Leadership Institute Board Meeting Participants:

- Since July 1, 2019, 405 CGTC faculty and staff members have completed 3,307 training modules. These include Disabilities/504, Sexual Harassment, Unlawful Harassment of Staff and Students, Computer and Internet Use, Motivating Adult Learners, Bloodborne Pathogens, Title IX Legislation, Hazardous Materials, Part One and Part Two, Learning Disabilities, Employee Health, and others.
- Researched and presented a series of professional development sessions titled <u>Pedestal: Student Centric</u> <u>Instruction</u>. Twenty-five faculty members participated in the four-session series. These sessions included <u>Under-prepared Students</u>, <u>Student-Centered Teaching</u>, <u>Teaching Students How to Learn</u>, and concluding with <u>Building a</u> <u>Prep Program for Under-Prepared Students</u>.
- Following this experience, collaborated with RN faculty to create a four-day workshop, the Nursing Expectations Workshop for Beginners (NEWB), for under-prepared students that was delivered to thirty-six entering RN students in the first week of the term. Composed a survey instrument to serve as a pre-test/post-test to determine the impact the workshop had on students, in particular their perception of the program and their expectations. Performed an analysis of the results:
  - Question 24 showed a statistically relevant increase (Z-score>1.00). "I plan to continue to work part time during the course of the nursing program"; this suggests the NEWB activity led them to believe in the possibility of being able to manage a part time job with the rigor of coursework.
  - Question 9 showed a Z-score of 0.96, not quite statistically relevant but worth noting, "I am confident that I will function well during CGTC nursing examinations"
  - Questions 26 showed the greatest decrease in Mean scores, "I know how to manage my time effectively" decreased from a pre-test response Mean of 3.67 to a post-test Mean of 3.06. This response might be from a greater awareness of the time management needs for the program. The reality of the volume and intensity of the academics might be more apparent to students following the NEWB workshop.

- Question 18 is interesting, "My family is supportive of my attending the nursing program at CGTC" had a unanimous pre-test result of "Strongly Agree"; the post-test result showed seven students answered "3", or "Agree" on the post-test. This suggests their support at home decreased over the course of the four-day workshop, which is confusing. Perhaps their focus on the survey questions was increased and the value they placed on accurate answers became greater?
- Further analysis is needed as students progress to determine long-term impacts of the NEWB activity.
- Conducted the <u>*Teacher Education Academy*</u> for ten newly hired full time faculty. This three-day workshop covers the structure and purpose of the College and TCSG, understanding our students, teaching and assessing our students, and a number of the policies and procedures relevant to instruction. A follow-up survey indicated 100% satisfaction from those participants.
- Researched and presented professional development sessions on <u>*Retention*</u> that discussed national best practices for the classroom. Local faculty best practices were also included; also reviewed the definitions and the formula for calculating retention used by TCSG. Reviewed those programs at the three levels (TCC, Diploma, and Degree) with the best rates and those most challenged. Competitive selection was also discussed and the need to improve advisement with students not selected.
- Conducted training on <u>Advisory Committees</u> for 28 faculty and staff members.
- Conducted research with Ms. Robin Carr from the Adult Education regarding the success rates of GED students post-transition to credit instruction. iNET report **405 HS Diploma and GED Grade Comparison** was created by IT staff. This report excludes those students reporting 13 years of education and further, to include Associate diplomas, degrees and higher. From that pool, the grade distribution is reported for those students entering CGTC with only a High School diploma (HS) or those entering with only a GED. The report was run for three consecutive Fall terms: 202012, 201912, and 201812. There were 9,812 grades (duplicated) for HS graduates and 3,871 grades (duplicated) for GED graduates.

• From that data, a calculation was made on the attainment rate of each group. Attainment in this instance refers to the rate of success of students in the course. That is, the rate of final grades of A, B, or C compared to final grades of A, B, C, D, or F. W grades are excluded. The report provides two groups of course results: Academic and Occupational.

• The preliminary data for Academic courses shows mixed results but a more favorable attainment rate for GED graduates. *Table 1* below shows the number of courses with less than a 10% difference in attainment rate between the two groups, which is considered favorable and perhaps the goal. Of the courses with more than a 10% success rate for either HS graduates or GED graduates, GED graduates had greater instances of success over their HS counterparts.

• The same report was run for Occupational courses and results appear to diminish for GED graduates. There were 421 such courses over the three terms, 59% of which indicated a difference of less than 10% for either group, which one might consider the goal. *Table 2* below shows the results of each term.

Regarding occupational programs, there were no programs in which HS graduates outperformed GED graduates consistently.

## <u>QEP</u>

- The ALFAA Refresher training was conducted on each of the three main campuses and via Telepresence to over eleven faculty and staff members.
- Since the inception of ALFAA, the average percentage of students recorded as having been ALFAA advised each academic year has steadily increased (30% in AY2016; 31% in AY2017; 36% in AY2018; 42% in AY2019), leading to a 134% increase (38% in the baseline year versus 89% in AY2019) of the number of students who are able to demonstrate knowledge in using college success resources as well as registration and withdrawal procedures.
- This trend of increased emphasis on ALFAA advisement and increased student knowledge, autonomy, and efficacy has led to a year-to-year increase in the overall, unduplicated number of the institution's graduates (3,474 in AY2017; 3,690 in AY2018; 4,194 in AY2019) and awards (6,012 in AY2017; 6,084 in AY2018; 6,850 in AY2019), the highest number of awards for any college in the Technical College System of Georgia.
- Researched and developed a new training session, <u>Advising Students</u>, that discussed strategies for best serving students with the philosophy of "Any Student, Any Where, at Any Time *can be advised by* Any Faculty Member, Any Where, <u>Every</u> Time". In particular, the unique needs of First Generation Students (40.6% of CGTC enrollment) was reviewed in depth. Over 23 faculty and staff members attended on the Warner Robins and Macon campuses.
