PROGRAM EXPANSION REQUEST

ASSOCIATE OF SCIENCE IN NURSING (AN43)

Proposed Expanded Location: Milledgeville Campus

Proposed Date of Implementation: Fall Semester 202312 (August 2022)

Program Description: The two-year associate level nursing program is a sequence of courses designed to prepare students for positions in the nursing profession. The curriculum is designed to produce highly trained, technically advanced, competent and caring individuals who are prepared to practice professional nursing in a variety of healthcare settings. The purpose of the program is to provide the learner with the necessary knowledge, skills, and attitudes to practice competently and safely as a beginning nurse generalist in a variety of acute and long-term care settings. Program graduates receive an Associate of Science in Nursing (ASN) degree. Program graduates who meet exit requirements will be eligible to apply to the Georgia Board of Nursing to write the national licensure examination (NCLEX) to become registered nurses (RNs).

Statement of Need for Program in the Service Area: CGTC currently offers the ASN program in Warner Robins, with consistently more qualified applicants than available spaces.

Clinical partners in the Macon-Bibb and Baldwin counties have demanded expanding the current ASN program to meet the demand for licensed RNs in these areas. The Division of Nursing Advisory committee, confirmed the need for nurses and approved the expansion to the Milledgeville campus. They are willing to support the addition with clinical space, clinical instructors, and part-time/guest lecturers.

According to the GA Department of Labor, employment of RNs is expected to grow much faster than the average, resulting in a large number of new jobs. As of July 19, 2021, there are 98 open positions for new RNs at Atrium Health spanning Peach, Baldwin, and Macon Georgia, specifically 20 in Milledgeville and 75 in Macon. There are 318 open positions within the Piedmont hospital system and 65 open positions at Houston Healthcare. The average hourly RN rate in central Georgia is \$28.

Recommendation: That the above program of study be approved for expansion to the Milledgeville Campus.

NEW PROGRAM REQUEST

IOS APP DEVELOPMENT IN SWIFT (IAD1)

Technical Certificate of Credit

Proposed Date of Implementation: Spring Semester 202214

Location: Online

Program Description: The iOS App Development in Swift Technical Certificate of Credit prepares students for positions in app development for the Apple iPad, iPhone, and Apple Watch series. The program emphasizes the knowledge and skills required to design, develop, test, and document structured and object-oriented programs utilizing Swift and Xcode.

Statement of Need for Program in the Service Area: Employment of web developers is projected to grow 8% and software developers 22% from 2019 to 2029, both much faster than the average for all occupations. The main reason for the rapid growth in both applications developers and systems developers is a large increase in the demand for computer software. The need for new applications on mobile devices will help increase the demand for application software developers.

Information Items

Engineering Technology

Nine CGTC students successfully completed paid summer internship experiences with the following companies: Frito Lay/Gilmer Packaging, Baxley Electrical, BASF, YKK, Graphic Packaging, RAFB (Robotics Lab, Electrical Lab), Daikin Lab.

Cosmetology

All three campuses had a combined 88% combined pass rate for FY2021. Of the 40 students who tested, 35 students successfully passed both required sections (written and practicum).

Dental Hygiene

To date, the Class of 2021 graduates for both campuses currently have a licensure pass rate of 80%. Also, both campuses participated in the Farm Workers Family Health Program in Moultrie this summer. They were able to apply fluoride and sealants for the children at Cox Elementary School. Students applied 313 sealants for children who are at a high cavity risk and who would not receive the services elsewhere. This is a multi-school/multi-disciplinary collaboration with Emory University done each June (with the exception of last summer due to COVID). Other schools participating this summer included the University of Georgia, Georgia State University, and Brenau University. Other services provided for the children and adult farm workers were nursing, physical therapy, hearing and eye screenings, psychological services, etc.

Orthopedic Technology

Three graduating students that will be able to sit for their licensure exam in October. Each student has been offered and accepted a job in Orthopedic Technology at local private office and Hospital.

Nursing

30 of 31 graduating students have taken the NCLEX licensure exam. Of those 30, 26 passed on the first attempt (86.7% pass rate). ACEN accreditation requires a first time pass rate of at least 80%.

The publication is distributed each semester providing the College community with institutional outcome progress, professional development sessions and participation data, grant updates, accreditation news, as well as student success initiatives.

The College is required to disclose certain information as determined by the federal government under the Higher Education Opportunity Act of 2008. Institutional outcomes and programs offered annual performance data are displayed on the College's website from the IE Publications links. These pages are updated once data are final for the term or end-of-year.

Achieving the Dream - As a member of Achieving the Dream, the College has access to a great number of tools, including the Institutional Capacity Assessment Tool, or ICAT. The ICAT was introduced to College faculty and staff via email on February 25, 2021. There were 275 respondents to the survey.

Analysis can be made of those questions with a higher rate of the least desired Level 1 and Level 2 responses, those questions with a high rate of the desired Level 4, those questions with a high rate of "I Don't Know, and further, if a particular area of the College (Academic Affairs, Student Affairs, etc.) or if a particular functional role (Administrator, Full Time Faculty, etc.) indicates a greater rate of "I Don't Know" for a particular question.

2021 Results:

The College results indicate an Exemplary level of capacity in each of the seven dimensions, as we have for each delivery of the ICAT (2019 and 2017 previously).



- The growth in early alerts worked by CGTC's TEAMS Outreach Center (TOC) nearly tripled between Summer 2018 and Summer 2020 from 129 alerts to 363. Alerts continue to be high with a total of 301 alerts for the Summer 2021 semester.



Professional Development.

Maintaining the format and structure of Professional Development Day should continue. Topics suggested for future sessions are being applied toward Summer and Fall term professional development planning and will be offered. Constructive and negative comments are also being addressed; these include a greater value placed on the mandatory sessions as being meaningful to all faculty and staff, as these topics regard both updated information on Academic Affairs and Enrollment Management as well as Unit Planning, both of which are important to each member of each unit. Each of the other categories of constructive comments will be considered when planning the next Professional Development Day to include a call for topics for faculty and staff and a more thorough description of the naming convention for the sessions.

Following analysis of these results, sessions were created and/or re-offered during Summer term and more plan to be during Fall term. During Summer term, sessions were held on Financial Aid and Online Instruction as a direct result of the survey. In addition, a series of training sessions were built based on Microsoft Excel based on 15-minute lunchtime schedule. These are also recorded and made available to faculty and staff.
