Location: Emanuel State Prison

Program Description: The Travel and Tourism Associate technical certificate which prepares students to work for convention and visitor bureaus, cruise lines, travel agencies and destination management companies, and other enterprises involved in the planning and implementation of individual and corporate travel programs. Topics include the travel industry, travel geography, tour and cruise management, hospitality law, and business etiquette and communication.

Statement of Need for Program in the Service Area: Lodging managers ensure that traveling guests have a pleasant experience at their establishment with accommodations. They also ensure that the business is run efficiently and profitably. Employment of lodging managers is projected to grow 9 percent from 2020 to 2030, about as fast as the average for all occupations.


