Academic Affairs Update CGTC Board of Directors Meeting

Distance Education

Central Georgia Technical College was recognized in the November 25 edition of *Newsweek* magazine as one of America's Best Online Learning Schools for 2023. CGTC is the highest ranked two-year college in the nation on the list, and the third highest ranked institution of higher education in Georgia.

Aircraft Structural Technology

Christopher Garcia-Hernandez, was the first Option B student to complete the program. He has already obtained employment in the field as an Aircraft Composites Technician for H2 Aeroservices, repairing composite aircraft components.

Dental Hygiene

Four dental hygiene students participated in the study abroad trip to St. Vincent. The students were able to see over 40 patients at 3 different poly-clinics across the island. We were also able to visit a preschool, a primary school, and an orphanage where they provided toothbrushes and oral hygiene instruction. They will graduate in May with an appreciation of global dental needs in addition to the skills they learn in the classroom.

Nursing

Seven nursing students accompanied Jessica Willcox, CGTC Director of Nursing, on the St. Vincent study abroad trip. Students received hands-on experience at the Milton Cato Memorial Hospital and hosted a Teddy Bear Clinic at the St. Benedict's Orphanages with Operation Healing Smiles. Jessica Willcox also taught continuing education courses for the nursing faculty of St. Vincent and the Grenadines Community College (SVGCC) and is now licensed as a nurse on the island.

Paramedicine

Two CGTC paramedic students worked alongside the nursing and medical staff at in the Accident and Emergency (A&E) ward at Milton Cato Memorial Hospital in Kingstown. The students were able to work within their stateside scope of practice (Starting IVs, 12 lead ECGs, bandaging, splint, etc). They were also able to assist with the nursing procedures alongside our nursing students. The ambulance service is hospital based where a nurse from the A&E ward serves as the attendant on the response. CGTC students accompanied the nurse on the ambulance where they assisted in multiple responses including motor vehicle accidents, trauma patients coming in by ferry and unconscious subjects. The staff at Milton Cato stated they learned a lot from CGTC's participation on the ambulance and the integration of Georgia prehospital care with that of St Vincent's.

FIREFIGHTER I (FF11)

Technical Certificate of Credit

Proposed Date of Implementation: Fall Semester 2023 (202412)

Location: William S. Hutchings College and Career Academy, Macon-Bibb County Firefighter Training Academy

Program Description: The Firefighter I Technical Certificate of Credit program is conducted in cooperation with the Georgia Fire Academy and Georgia Firefighter Standards and Training to ensure graduates have the skills, knowledge and credentials to serve as firefighters in paid and volunteer fire departments. Graduates will be tested and certified at the state level.

Statement of Need for Program in the Service Area: Due to a shortage of qualified firefighters, Macon-Bibb County Fire Department and Hutchings College and Career Academy requested a partnership with CGTC to offer this Firefighter I TCC through dual enrollment. Essential equipment will be purchased and furnished by the fire department and Bibb Co Career Academy. The program will give the dual enrollment students the opportunity to interview with Macon-Bibb County Fire Department.
