

<u>Grants</u>


The Institutional Effectiveness Division provides significant support for grant applications and other competitive funding sources. As a result of these efforts, CGTC was awarded over \$4.9M in FY2022 with 60% from federal sources, 25% from local governments, 9% from philanthropic sources, and 6% from state funding as shown in the following chart.



*Federal funds received through the Higher Education Emergency Relief Fund (HEERF) and State pass through Carl D. Perkins funds are omitted.


During FY2022, 18 applications were submitted for grants and competitive funding totaling \$14,867,584. Of those applications, 56% have been awarded to CGTC or the CGTC Foundation resulting in an additional \$8,811,426 in funds. Four applications, valued at \$2,501,158, are still under review. To date, only four applications submitted in FY2022 have not been funded.

The Institutional Effectiveness Division pursues funding to support all divisions of the College. Both Academic Affairs and the Executive Vice President (VECTR, High School Initiatives, and Campus Security) Divisions received approximately \$1.5M from grants and competitive funding sources as these areas work directly with students to provide quality programming and services to improve student learning.




Carl D. Perkins Grant

The Perkins grant is Federal funding provided to the College through TCSG and the Georgia Department of Education (GADOE). Allocation of funding is not competitive but based on the number of Pell recipients. The College's allocation for FY2023 is \$1,625,612 and is distributed among Divisions that provide eligible activities in support of grant priorities.



Perkins funds are disbursed to support the following categories, Personnel, Equipment, Travel, Professional Development, Books and Supplies, Contracts and Consultants.




Perkins funding supports negotiated activities devised with internal and external stakeholder input. External stakeholders include but are not limited to secondary school systems, business and industry partners, and WorkSource Georgia Region 6 entities. Local Board and Foundation Board members are considered as internal stakeholders for planning purposes. The College is preparing to conduct the grant required stakeholder sessions to develop the next Comprehensive Needs Assessment Plan.

The Office of Institutional Effectiveness provides grant management and technical assistance to College departments such as Special Populations. In FY2022, the Office of Special Populations, a unit of the Student Services Division, as recipients of Perkins funding, provided Lending Library services to 207 students throughout the academic year. Many students received assistance during one or more semesters in fall, spring, and/or summer semesters. Of the 207 students assisted, 78% successfully passed their courses and 7% of the students who were eligible successfully graduated from their program of study. Fifteen percent (15%) of the students receiving assistance failed their courses and were contacted by a representative from Special Populations and the TEAMS Outreach Center for intervention strategies. The Office of Special Populations projects to serve 300 individual students in academic year 2023 with 171 students serviced currently in Fall semester 2022.

Planning and Assessment

Assessment and planning activities are an on-going process at CGTC. The College reports results at various intervals during and at the end of year so that persons responsible for planning can assess results, devise strategies to seek improvement where needed or close out current plans, develop new plans for the coming fiscal year and carryout the activities of the new plans. During the months of September through October, persons responsible for planning await end of year reports from TCSG to finalize their plans. Current progress towards completion of the FY2022 planning cycle is demonstrated in the tables below.






Student Success

TEAMS Outreach Center

In an effort to make TEAMS Outreach Center (TOC) services more convenient for CGTC students, a self-alert submission link was added to the College's single sign-on dashboard. This allows the TEAMS Outreach Center to connect each student to the correct department or resource needed. The self-alert is also a way for the student to be introduced to the TEAMS Outreach Center and the services offered.

The top five categories of students seeking assistance are Financial Aid, Registration, Academic, Laptops and Books. This data also helps us to identify existing gaps that can be addressed for future semesters. Some changes have already been implemented to create self-help guides in graphic interchange format (gif) to help students navigate registration, drop add, and other banner processes more easily. This implementation resulted in an immediate drop in self-alerts for this category. The TEAMS Outreach Center continues to monitor data for new trends and information to better serve CGTC students. REACH Student Organization

A QR code was added to the flyer to give the ability to listen to the featured REACH involvement testimonial episode where Rolandria Tolbert, IE Project Specialist/ REACH Coordinator participated in a Titan Talk Podcast with guests Barry Smith, REACH student, and his mother, Alice Smith, to share the impact of REACH activities on the academic success and leadership development of male students of color.

CGTC REACH Mentors will attend the MENTOR Georgia Summit on September 6th for a full day of professional learning and networking for programs looking to deepen and inform their mentoring practices. There will be sessions on best practices to help students both academically and socially to enhance soft skills and leadership practices.
