##### *CURRENT – RENEWED*

Academic Affairs is working on re-signing the following articulation agreements. These agreements will be a refresh to older agreements:

- 1) Fort Valley State (AS in General Studies)
- 2) MGSU (Criminal Justice)
- 3) Gordon State College (AS in General Studies)

##### *NEW*

- 1) Trinity School of Medicine (AS in General Studies for Medical Professions)

##### *LPN/Paramedic to ASN Bridge*

Central Georgia Technical College received approval from the Georgia Board of Nursing on July 13, 2023 to offer an accelerated Nursing Bridge program for LPNs and Paramedics, to advance their nursing knowledge and become registered nurses through the Associate of Science Nursing (ASN) program. The college is sharing this great news with students and former graduates, and plans to select the first cohort of twenty-five (25) students into the program in the Spring of 2024 with enrollment in the initial nursing classes in Summer of 2024. This program's curriculum will be delivered in an online, evening, and weekend format; in order to, minimize the potential burden on the work schedule of the LPN's and paramedics who enroll in the program. "This program will bring great benefits to our students, community, and healthcare partners", and "through this program, we will nurture and inspire a new generation of compassionate nurses with diverse experiences and knowledge," shared Jessica Willcox, CGTC Director of Nursing.

##### *Georgia AIM*

The new AI Enhanced Robotic Manufacturing Specialist TCC program launches instruction on October 10, in just 61 days! Our current focus is on finishing the details of the studio space and developing the Blackboard shells for the new AUMF courses. (Automated Manufacturing Skills, Cyber-Physical Systems, Introduction to Robotics, and Machine Vision Fundamentals).

We have already received 4 applications for our first cohort. With a capacity of 15 students, we expect more seats to be filled once our program is approved and listed on the DOD SkillBridge website, any day now. Please encourage students to apply.

Major wins this month include:

- Attainment of 2 Instructor level Certifications from FANUC America, which will allow our students to receive two different industry recognized certifications from FANUC as Certified Robot Operators in addition to credited completion of FANUC's HandlingTool Operations and Programming course.
- Our portion of the Georgia AIM grant funds being raised by a little over \$106k from \$950,800 to \$1,057,298.
- 1 Robot trainer, PLC Trainers, and 3D printer moved from Macon and setup in the new VECTR Studio. The equipment we have on order is currently estimated to ship mid to late October, so this will be used to begin training ahead of receipt.
- Completion of the first section of our new AUMF 1300 AI in Manufacturing course which was offered online during Summer Term.

#### *CAE-CD*

The Center of Academic Excellence in Cyber Defense (CAE-CD) designation is administered by the National Security Agency(NSA). The designation is awarded to academic institutions offering cybersecurity-related degrees at the Associates, Bachelors, and graduate levels. Institutions seeking this designation will apply in two parts: Program of Study Validation and CAE-CD Designation. CGTC received Program of Study Validation on June 21, 2023. The program is validated until June 2028. The application for Part II was submitted on June 30, and the NSA has assigned a review committee chair.

Associate of Applied Science Degree

**Proposed Date of Implementation:** Spring Semester 202414

**Location:** Warner Robins, Macon, Milledgeville Campuses and Online

**Statement of Need for Program in the Service Area:** The current Business Technology degree program was last fully revised in 2010. Since the last revision, industry standards and the application of technology have significantly changed, thus calling for a demand to meet the needs of our community and industry partners within our service area.

The implementation of the updated business technology program would allow students to advance their knowledge of business-related technology software, programs, office management and executive assistant qualifications and technology innovations for the office through the offering of specific high-demand specializations in office management, project management, human resources, and social media which are not currently offered.

Based upon the review of extensive discussion with the advisory committee and community members, there is increased demand for healthcare industry professionals to enter the workforce as office and administrative support workers, supervisors, and managers who show leadership and team-building skills, who exhibit critical thinking skills, and who can multitask, communicate well, and keep abreast of technological advances.

**Program Description:** The Business Technology program is designed to prepare graduates for employment in a variety of positions in today's technology-driven workplaces. The program emphasizes the use of word processing, spreadsheet, presentation, and database applications software. Students are also introduced to accounting fundamentals, electronic communications, internet research, and electronic file management. The program includes instruction in effective communication skills and terminology that encompasses office management and executive assistant qualification and technology innovations for the office. Additionally, the program provides opportunities to upgrade present knowledge and skills or to retrain in the area of administrative technology.

**Statement of Need for Program in the Service Area:** Healthcare professionals are a critical part of all aspects of the healthcare delivery system. As the demand for quality healthcare services continues to rise and the healthcare landscape evolves, it is crucial that we adapt and equip our students with the skills and knowledge required to meet the industry's changing demands. The healthcare sector is currently facing numerous challenges, including a shortage of qualified professionals. ### Information Technology

#### Filled Positions:

Collaboration with the Georgia Institute of Technology and Pennsylvania State University would allow 15-20 CGTC Engineering Technology students to participate in summer internships focused on technological and design challenges of hybrid concept aircraft. Award announcements for Phase A proposals are anticipated by early October. If approved, partners will develop a detailed Phase B application.

Tech Hubs program [US Economic Development Administration]

Commitment to engage in a consortium led by the Georgia Institute of Technology that would accelerate the growth of clean technology and clean energy sectors within Georgia. Award announcements for Phase 1 proposals are anticipated by early October. If approved, partners will develop a detailed Phase 2 application.

SOAR (Supporting STEM Opportunity and Access in Rural Georgia) [US Department of Education's EIR (Education Innovation and Research) program] as a collaborative partner with Georgia Leadership Institute for School Improvement, Dr. Leslie Bussey, Executive Director. Partnership to support STEM education in rural communities more specifically Twiggs County.

#### **Ad Hoc Reports**

The Best for Vets survey for AY2023 was submitted in July. Data gathered for the survey showed that military students are outperforming the overall student population in both average GPA and retention.

Military students earned a higher average GPA in Spring 2023 than the overall student population (non-military), regardless of enrollment status.

Retention is also higher for military students than for the overall student population. Many military students are enrolled in accelerated programs offered through the VECTR Center and graduate within the first year of enrollment. In this context, retention is defined as the percentage of students who began in Fall 2021 and completed or reenrolled Fall 2022

Satisfaction surveys were conducted for faculty and staff participating in various internal professional development activities:

- Professional Development Day, over 90% satisfaction on each of the four measures
- Professional Development general sessions, over 95% satisfaction with each of the four measures
- Professional Development recordings, over 94% satisfaction on each of the four measures

The Teacher Education Academy was provided for 11 participants

The Titan Leadership Institute was provided for 12 participants

In response to college-level retention data from AY2022, the Good to Great Retention series was created and offered during AY2023 as both live WebEx sessions and recordings. Participation levels were achieved through the completion of 4, 6, 8, and 10 sessions for the Titan, Bronze, Silver, and Gold certificates, respectively.

- 98 hours provided via WebEx
- 99 hours provided as recordings of previous sessions
- 23 faculty and staff members achieved the Titan level certificate
- 8 faculty and staff members achieved the Bronze level certificate
- 6 faculty and staff members achieved the Silver level certificate
- 4 faculty and staff members achieved the Gold level certificate
