New Designated Approvals

NSA CAE Designation Approval - Computer Information Systems Technology (CIST) Department

On August 24, 2023, CGTC and the CIST department received notification from the National Security Agency (NSA) that Central Georgia Technical College has been designated as a National Center of Academic Excellence in Cyber Defense (CAE-CD) for the validated programs of study through academic year 2028. Central Georgia Technical College will be listed as a CAE-CD on the <u>CAE Institution Map</u>. The National Cyber Strategy addresses the critical shortage of professionals with cybersecurity skills and highlights the importance of higher education as a solution to defending America's cyberspace. A highly skilled cybersecurity workforce is a strategic national security advantage. The NSA letter of designation states that "the United States Government will continue to invest in and enhance programs that build the domestic talent pipeline, from primary through postsecondary education. Education is the key to promoting these ideals." Felicia Everidge, instructor, was the point of contact for Part I (Program of Study Approval), with Bridget Willis, Division Head, as the alternate POC. Ms. Willis was the POC for Part II (CAE-CD) designation. Other faculty lending support of this process (data collection/teaching) were Jackie Farms, Program Chair and Cyber Club Advisor, and instructors Jim Pund, Alesia Sikes, and Lori Harnist(retired). David VanLandingham, Director of Research and Compliance, was very instrumental throughout this process as well. ABA Approved Program - Paralegal Studies (PARA) Department

On August 15, 2023, CGTC and the Paralegal Studies department, led by Jacqueline Hightower (Program Chair), received official notification that the House of Delegates of the American Bar Association granted initial approval to the Paralegal Studies Program at Central Georgia Technical College for a period of seven years, beginning August 2023 and ending August 2030.

Instructor Certifications

CDL Third Party Examiner Certification - Commercial Truck Driving (CTDL) Department

Central Georgia Technical College (CGTC) is a third-party testing site for the Georgia Department of Drivers Services (DDS), with multiple faculty members serving as examiners. This allows CGTC to provide examination services for all classes of Commercial Driver's License (CDL), creating a seamless training experience for students enrolled in the Commercial Truck Driving Program (CTDL). Additionally, the ability to offer third-party examination services has proven to be an invaluable resource for industry partners such as Robins Air Force Base, Macon Water Authority, and the Georgia Forestry Commission, who have relied upon CGTC for both training and examination services. Two faculty members, **George Ireland** and **Jonathan Rogers**, earned their CDL Third Party Examiner Certification last month to join two others who already hold this certification, **Tim English** and **Sharoko Farley**.

FANUC Instructor Certification - AI Robotics

Deryk Stoops passed exams to earn the designation of FANUC Certified Robot Operator Instructor and FANUC Certified Applied Robot Operator Instructor. The new program, AI Enhanced Robotic Manufacturing Specialist TCC, will begin in October 2023.

Federal Aviation Administration, Designated Mechanic Examiner (DME) Certification

Mike Pace has been selected to be a Designated Mechanic Examiner (DME) for the Federal Aviation Administration. This is a phenomenal achievement and honor for our college to have it's own DME to not only service our students, but students from across the region on both the credit and non-credit areas of the college. These are coveted positions of which there are only a handful in the state, and it has taken many years for the college to get our own DME. Having an in-house DME can only enhance our standing with the FAA and the communities that we serve.

On October 10, 2023, CGTC will host a "TCSG Aviation Listening Session" with representatives from the Technical College System of Georgia (TCSG) and aerospace industry partners from around the region. 

Facilities Projects

- Macon "H" renovation (new RN program) and WR "C" renovation (Trade and Industry): Construction on both campuses is ongoing. The contractor is projecting an earlier-than-expected completion of Macon "H," and Phase II of WR "C" commenced August 15
- Macon electrical switchgear replacement (\$853K) was completed Labor Day weekend
- Macon ECCE/CDC bid documents have been submitted to TCSG for bid and are currently awaiting DOAS sign-off
- Building WR "G Extension" expansion (\$1.27MM) is complete and occupied
- Sports surface (\$1.69MM) commenced on April 10; projected turf installation began Monday, September 4; asphalt track by September 14; bleachers and press box December
- Access Control System for Milledgeville, Macon, WR, and VECTR (\$1.1MM) is operational and being debugged
- Air quality and controls upgrade project to include needlepoint bipolar ionization in 83 air handling units at Milledgeville, Macon, Warner Robins, and VECTR project is paused (~75%): \$640K; Meeting to include Siemens and TCSG procurement and facilities personnel
- Multiple parking estimates high: \$3.2 (projected)
- Major CO request for FY 24 Macon T and I renovation has been submitted and we are working on requested revisions: ~\$20MM
