Statement of Need for Program in the Service Area: The addition of the business health technology degree program would allow students to advance their knowledge of health-related technology software, programs, healthcare regulation, and compliance with specific advancements in specializations of healthcare administration, healthcare reimbursement, and health informatics which is not currently offered at the technical college level within our service area.

Based upon the review of extensive discussion with the advisory committee and community members, there is increased demand for healthcare industry professionals to enter the workforce as office and administrative support workers, supervisors, and managers who show leadership and team-building skills, who exhibit critical thinking skills, and who can multitask, communicate well, and keep abreast of technological advances.

The Bureau of Labor Statistics reported that the employment of healthcare support in physician offices and healthcare facilities is projected to be a fast-growing occupational group with a 17.8% growth from 2021-2031. According to the Georgia workforce statistical outlook, the growth in healthcare technical and support occupations is projected to be one of the fastest growing areas in the state, with medical records and health information technicians projected to grow faster than the state average. In response to these demands, the Business Technology faculty has elected to expand the single healthcare specialization in the current diploma program to all-encompassing business healthcare programs (degree, diploma, and TCCs).

Program Description: The Business Healthcare Technology program is designed to prepare graduates for employment in a variety of positions in today's technology-driven workplaces. The program emphasizes the use of software and technology. Students are also introduced to accounting fundamentals, electronic communications, internet research, electronic file management, and healthcare regulation and compliance. The program includes instruction in effective communication skills and terminology that encompasses office management and executive assistant qualification and technology innovations for the office.






CCAMPIS - Year 1: Student-Parent Outcomes





- Data collection for Year 2 reporting shows improved outcomes on project performance measures, including enrollment and persistence rates.
 - Unduplicated enrollment of African American male students in STEM and Health programs increased by 23%, from 810 in AY2022 (baseline) to 997 in AY2023, outpacing the 5% enrollment goal, as shown in the chart *Project CAFÉ Goal 1: Enrollment*.
 - Persistence rates for African American male students in STEM and Health programs improved by 3.8%, increasing from 60.1% in AY2022 (baseline) to 62.4% in AY2023, outpacing the goal of a 2% rate for annual growth, as shown in the chart *Project CAFÉ Goal 2: Persistence*.

In AY2023, CGTC had the highest number of graduates (unduplicated) and awards (duplicated) within the Technical College System of Georgia (TCSG). CGTC's performance accounted for 10% of total awards and 11% of total graduates systemwide, as shown in the table *CGTC Overall Award and Graduate Outcomes for AY2023*. Furthermore, CGTC led the system in high school dual enrollment outcomes. 

TEAMS Outreach Center


The TEAMS Outreach Center coordinates personalized outreach and wrap around support services to students facing academic barriers or personal hardships. Faculty or staff can submit an alert or students may self-alert.

TEAMS participated in new student orientations on all three campuses, three resources fairs, and two program specific orientations (Nursing and Radiology) to disseminate information on resources available at the College to reduce barriers to completion. Within the first five weeks of Fall semester, TEAMS processed 182 self-alerts for resource referrals, provided 28 loaner laptops, and reviewed 22 TEAMS Greatest Needs Fund applications.

The total number of alerts increased by 95%, from 2,273 to 4,421 between AY2022 and AY2023, as shown in the chart *Early Alert Trends – Assistance Provided*. The number of students with successful outcomes (reenrolled or graduated) after receiving assistance through the TEAMS Outreach Center also increased during the same period, as show in the chart *Early Alert Trends – Student Outcomes*.

Growth in utilization of the early alert system continues in AY2024. As the midway point in the semester nears, over 2,000 alerts have been submitted exceeding 64% of all alerts submitted in the prior fall semester (1,281), as shown in the table Early Alerts - Fall to Fall Comparison. CGTC continues to lead TCSG colleges in utilization of the early alert system with more than double the total number of alerts submitted and unduplicated students alerted of the next highest college, as shown in the table Top Five Colleges for Alerts Submitted for Fall Semester.
