Location: Warner Robins, Macon, Milledgeville Campus; VECTR Center

Statement of Need for Program in the Service Area: The Accelerated Orthopedic Technology Technical Certificate of Credit would support the educational and workforce development needs of its 11-county service area, which include: Baldwin, Bibb, Crawford, Dooly, Houston, Jones, Monroe, Peach, Pulaski, Putnam and Twiggs counties. Offering an accelerated Orthopedic Technology technical certificate could provide services on a global level. Our service area includes Robins Air Force Base and the accelerated program could offer military members who are transitioning from their dedicated service, and opportunity to enter the high demand, high skill health care workforce globally.

**Program Description**: The Accelerated Orthopedic Technology Technical Certificate of Credit is a sequence of courses involving a combination of didactic, laboratory, and clinical environments that prepare students to work in demand, high skills in a variety of health care settings to treat patients, including orthopedic surgeon. The accelerated program provides the skills and knowledge needed to become a competent orthopedic technologist performing the following services: applying, adjusting, and removing casts and splints; fitting and educating patients in the use of orthopedic braces and equipment; setting up, adjusting, and maintaining orthopedic traction configurations; assisting with the care of acutely injured patients; assisting the physician in the reduction and/or manipulation of orthopedic injuries; assisting the orthopedic surgeon in an operating room setting; and performing basic office and departmental procedures such as vital signs and patient medical history. Graduates may become employed in hospitals, physician offices, medical clinics, and orthopedic bracing and equipment companies.

## **General Information**

## Mechatronics and Electric Vehicle (EV) Expansion:

The project to expand Mechatronics and Electric Vehicle (EV) programming at the Milledgeville campus is well underway. Azar-Walsh Architects have been chosen for the design work, and Sheridan Construction will manage the project. The preliminary designs that will reconfigure the C-Wing to create a 4,440 square foot Mechatronics lab and classroom space are nearing completion. Additionally, the existing automotive lab will undergo modifications which include the addition of EV charging stations, battery storage, and general facility refresh.

The college will offer two Technical Certificates (TCC), a Diploma, and an Associate's Degree Program for Mechatronics. The curricula which have been selected share a high degree of commonality with our existing Industrial Systems Technology Programs which are being delivered in Warner Robins, Macon, and VECTR. Furthermore, an Electric Vehicle Repair Technician TCC will be offered in conjunction with the existing Automotive Technology Program, which is accredited through Automotive Service Excellence (ASE).

## Rivian Train-the-Trainer:

On August 6-7, CGTC hosted a training event at the Warner Robins campus delivered by electric vehicle (EV) manufacturer Rivian. Approximately forty automotive faculty from across TCSG came to learn about unique EV subjects such as routine maintenance, troubleshooting, and safety practices. The Rivian training team brought a variety of vehicles from their product line which included pickups, an SUV, and an Amazon delivery van. This training was incredibly valuable to faculty members as CGTC and other technical colleges across the system who have begun to implement EV training programs.







- The Milledgeville EV/Mechatronics project is moving quickly. The contracted design professional is Azar Walsh and the Sheridan Construction is the construction manager at risk. Design development/programming is almost complete, and the demolition package has been released to Sheridan Construction (CM) for pricing.
- Atrium Health/Sonny Watson light project is scheduled to begin September 9<sup>th</sup> and be complete by September 20<sup>th</sup>.
- The FY 25 Capital Outlay project (renovation of Macon Trade and Industry buildings) has been approved and funded (\$17.55 MM), and DP request for proposal date is projected (internally) for mid-August depending on the GSFIC workload/timetable.
- The FY26 capital outlay request has been forwarded to TCSG and is under review. The request is for funding to make significant infrastructure improvements:
  - Major HVAC components and controls
  - o Roofs
  - Parking lots
  - o Fire Alarm system upgrades
  - Ground water intrusion remediation
  - These projects are internally estimated at \$6.7MM plus escalation



## General Information

## Warner Robins Sports Field Press Box

The vendor has completed the Public Address system installation in the Warner Robins sports field press box and tested it. However, one piece of equipment was incorrect, and we are working with the vendor to replace it with the correct equipment. Network services are also online in the press box providing announcers, game recording cameras, and sports staff network and internet access.

## Warner Robins Watson Building

Faculty, staff, and classroom technology have been moved back into the areas of the Warner Robins Watson building impacted by water damage. We have replenished our stock of cabling materials and will complete the re-cabling project of the impacted wing as rooms are available.

## Instructional Technology

## Milledgeville Rennovation

In preparation for the renovation, all technology has been removed from the Milledgeville B wing. Some equipment has been re-allocated to the A wing, some has been placed in storage, and much has been flagged for surplus.

Network wiring for a new lab in the Milledgeville A wing to support a new computer lab has been completed. As part of this project, we also rewired the Academic Success Center in Milledgeville. Two rooms remain in the A wing that need to be rewired; they will be completed as room availability permits.

#### **Peach County**

Technology in the Peach County Workforce Development Center has been moved to provide space for the Peach County Board of Education. We are deploying Webex (formerly called telepresence) equipment, laptops, and laptop cabinets to the center to support teaching and learning.

## Information Technology

### Macon Power Outage

On July 31st, the Macon campus suffered from a power outage. Unfortunately, a failure in our backup generators caused most of our servers to go offline when the battery backups were depleted. We were able to get most mission-critical systems back online by 9 a.m. on August 1st, and all services had been restored by 11 a.m. We are working with a service provider to repair the generators so this does not happen again.

## **Cyber Security**

## CrowdStrike Incident

We were impacted by the CrowdStrike outage that occurred on July 19<sup>th</sup>. By 11 a.m. on July 19<sup>th</sup>, most mission-critical systems were remediated and back online. We spent the next few days manually remediating end-user computers that were impacted by the faulty update deployed by the vendor. Each system had to be physically touched and manually remediated, which took approximately 10 minutes per end-user system. While we do not have an exact count, we believe roughly 600 of the 1,600 computers we have with CrowdStrike installed were impacted by the faulty update.

## eCampus Participation and Planning

Faculty teaching hosted courses on eCampus are required to complete student learning outcome (SLO) assessment plans in the CGTC Planning System and IE staff upload results to the TCSG eCampus Faculty Module site. CGTC has an established eCampus process that follows the TCSG eCampus Procedure.

## **Carl D. Perkins Grant**

CGTC's FY25 Perkins allocation is \$1,595,240. Amended budget was submitted with no change to allocation July 25, 2024 with approval received on July 28, 2024.





## <u>Grants</u>

## **New Grant Application:**

*Nurse Education, Practice, Quality, and Retention (NEPQR) Workforce Expansion Program (WEP)* application in the amount of \$3,660,000 (across four years) requested to prepare ASN students to provide high-quality patient care in acute and long-term care settings in rural and underserved areas. Funding will support additional ASN faculty, simulation equipment, professional development, and stipends for students participating in this specialized training opportunity.

## **Revised Grant Applications:**

CMVOST (Commercial Motor Vehicle Operator Safety Training) budget reduced per request of the funder, Dept of Transportation FMCSA, due to availability of funding. Project funding requested in the amount of \$130,240 (originally \$198,778) across two years. Supports student (including military-affiliated student) enrollment and participation in Commercial Truck Driving to increase available graduates to fill critical shortages in the field. Funding will support up to 80 (originally 110) students' tuition and fee costs. Official award projected in September 2024.

## **Ad Hoc Reports**

Enrollment of student-parents and single parents was significantly impacted by the COVID-19 pandemic. In AY2019, CGTC enrolled almost 3,000 student-parents and approximately 35% (1,030) self disclosed as single parents. After several years of steady recovery, student-parent enrollment is still down 14% from pre-pandemic levels (2,966 in AY2019 versus 2,550 in AY2024). During the same period, enrollment of single parents declined 49% (from 1,030 to 526). Two sessions were offered on Professional Development Day to inform faculty and staff of campus resources available for student-parents: 1) Child of Titan (CoT) kits: Engaging children of parenting students on campus hosted by the Child Development Center and 2) TwoGen Supports for Parenting Students cohosted by Special Populations, Library Services, WIOA, Child Development Center, and DECAL.



## **Student Success**

#### **TEAMS Outreach Center**

The TEAMS Outreach Center (TOC) coordinates personalized outreach and wrap around support services to students facing academic barriers or personal hardships. As part of retention efforts at CGTC, the TOC serves at-risk students who are alerted by faculty or staff. All newly hired faculty are trained in using the early alert system. Efforts by faculty to support student success coupled with overall enrollment growth resulted in a 31% increase in alerts submitted during Summer semester 2024 compared with Summer 2023 and a 21% increase in alerts for the academic year overall.

The TOC facilitates financial assistance through the TEAMS Greatest Needs Fund for currently enrolled credit students facing unexpected expenses that are not covered by other resource partners and may otherwise prevent the student from continuing their education at CGTC. In Summer semester 2024, 13 at-risk students received a total of \$3,013 in emergency assistance for tuition, textbooks, housing, and transportation. An anonymous donation in the amount of \$5,000 was received in July to support the TEAMS Greatest Needs Fund.

### **REACH Student Organization**

The REACH Student Organization hosted five bi-weekly sessions during Summer semester open to all students. REACH also provides faculty/staff mentors and leadership development opportunities for male students of color to support academic success and preparation for the workforce after college.
