#### State Board Approves A.S. Degrees for CGTC

The TCSG State Board met on Thursday, August 7, 2025 at Central Georgia Technical College. The Board approved four Associate of Science degrees submitted by CGTC: A.S. in Education; A.S. in Social Work; A.S. in Psychology; and A.S. in Criminal Justice. Academic Affairs will finalize articulation agreements for all four programs with the Academic Affairs team at Middle Georgia State University this month with a signing between Presidents and Institutions to follow.

#### CGTC Cybersecurity Club Student Wins 1st Place at SkillsUSA Nationals – Kaleb Brown

Kaleb Brown, a Cybersecurity Club student, won 1st Place in Computer Programming at the SkillsUSA National Competition held in June! This was a huge national-level achievement and a reflection of the hard work, talent, and dedication Kaleb has put into his craft. He represented our club and school with excellence, and we couldn't be prouder. A big thank-you also goes out to Mr. Burrows and Dr. Opoku-Fianko for supporting Kaleb throughout the week-long event and making sure he had everything he needed to compete and succeed.

#### Federal Aviation Administration Visit

The visit with the FAA went extremely well. The inspectors were highly complementary of the work the AVMT team has done and they officially gave their approval for the program to move forward with launching our first Aviation Maintenance course with an online presence. Our FAA administrators confirmed Central Georgia Technical College will be the first TCSG institution in the state to establish an online footprint within an AVMT program. It was also mentioned during the visit that Middle Georgia State University does not currently offer

distance learning options in their AVMT program. We are awaiting final approvals from the Distance Learning department to ensure we can move forward in time for the fall semester. With that support, we'll be ready to launch this course and begin paving the way for more flexible and accessible learning opportunities in our program. A special thanks to Brian Wynne, General Education Math instructor, for assisting the AVMT team with building the MyOpenMath platform for the class.







## **Facilities Projects**

- Milledgeville EV and Mechatronics Labs Renovation is complete, and the State Fire Marshal has issued a Certificate of Occupancy
- The FY 25 Capital Outlay project (renovation of several Macon campus buildings) project is in the contruction documents production phase. The initial estimate by the construction manager has (not unexpectedly) driven some modification to the initial schematic design to bring the project cost within the Guaranteed Maximum Price (GMP).
- The FY27 capital outlay requests are now under consideration by the Commissioner and State Board.
   The requests are to renovate the remaining portions of Building A in Milledgeville (9.855 MM) and renovate Buildings A and B in Warner Robins (22.87 MM).
- As previously mentioned, CGTC's FY27 System-Wide Critical Infrastructure supplemental Major Repair and Renovation (MRR) funds request has also been submitted to TCSG. The request is for funding (10.5MM) to make significant infrastructure improvements.
- The College is developing a minor project to build out and equip a Welding lab/program by renovating existing space on the Milledgeville campus. The project would be funded by using residual funds from the WAM (EV/Mechatronics) project (~800 K).

#### General Information

#### Video Conferencing Equipment

Video conferencing equipment in the Macon, Milledgeville, and Warner Robins Watson board rooms has been upgraded. The new equipment has higher resolution cameras and more sensitive microphones, providing a better experience for remote meeting guests.

#### Computer Replacement

In preparation for Windows 10 reaching end of life in October, the college has ordered approximately 550 new computers. The new computers have started arriving, and we are working with departments to schedule their installation. Our initial focus is on Academic Affairs classrooms to support student learning. The upgrade and replacement plan will impact every campus and location in some way.

#### Webex Calling (office/desk phones)

The college is moving forward with a transition from a self-hosted telephone system to Webex Calling. The transition will provide the most secure system possible, additional functionality for end users, and ensure compliance with E911 regulations.

# Cyber Security

#### **Phishing Attacks**

Many government agencies have experienced an increase in phishing attacks. CGTC is not immune to these attacks; we have noticed a dramatic increase in the attacks over the past few weeks. We are constantly tuning our filtering software to block phishing attacks and minimize the impact. We are also removing malicious messages from our system as they are identified. Over two days (July 30<sup>th</sup> and August 1<sup>st</sup>), we removed well over 10,000 malicious messages from our system.

#### Milledgeville Network

All of the network switches on the Milledgeville campus have been upgraded with new hardware. Many of the switches, while still functional, were "end of life" and were no longer supported by the manufacturer. The new hardware provides better network performance, stability, and an improved experience for our faculty, staff, and students while ensuring security and feature updates are available.





# Regional STEM/Allied Health Academy



#### **Purpose**

The Regional STEM/Allied Health Academy represents a partnership between the Houston County School District (HCSD), Central Georgia Technical College (CGTC), and partnering central Georgia Healthcare Systems, aimed at addressing the critical shortage of healthcare workers in the middle Georgia region. By integrating the Allied Health Alliance into the Academy, we aim to provide students with hands-on, career-focused education in healthcare, ensuring

a robust pipeline of skilled workers to meet the region's growing needs. This regional program will also welcome students from outside Houston County, expanding its impact across the Middle Georgia area.

#### **STEM Academy Partnership**

- Goals were established to ensure all programs are accurately represented.
- The specific needs for each program were discussed for supplies, equipment, and locations.
- Clarifications were mentioned making sure the program aligns with the commitments made to potential donors and partners.
- To maximize the use of spaces, block scheduling for classes should be considered.
- The laboratory classroom size will allow 24-28 students in 800 sq. Feet.

#### **Sharing Spaces**

- Licensed Practical Nurse, Certified Nursing Assistant, and Medical Assistant programs will share space.
- Cardiovascular Technology, Radiologic Technology, and Diagnostic Imaging (including ultrasound) will share space.
- Surgical Technology and Orthopedic Technology will share space.
- Emergency Medical Technician, emergency medical response, respiratory therapy, and polysomnography will share space.
- Medical Laboratory Technology, Medical Assisting Technology, Phlebotomy, and Hemodialysis will share a space.
- Pharmacy Technology will be in one of the classrooms.
- There will be 5 labs instead of 4.

#### **Cybersecurity Set Up**

- Business & Computer Technologies preferred double monitors (considered size 20-24 width x 42-46 height) for effective teaching environment. (Enough monitors for 20-26 students)
- Cybersecurity will be the same as computer support.
- Supplies needed for the lab included large chairs, room décor for game design. (Dedicated server room with Apple Computers)
- Space sharing is acceptable for Cybersecurity, Information Support, Computer Program but it's preferred that they are separated.

#### Aerospace, Trade, & Industry

- Sufficient spacing is needed for compressed air, electrical power, table space, and equipment.
- Plans include two general science laboratory and two math classrooms.
- The science laboratories will be consistent with standard high school laboratories.
- The math classrooms will have thirty desks.

- So far, Strategic Initiatives has received fifteen letters of support. Ten of the letters are from school districts and five are from healthcare partners.
- We have presented the Healthcare Partnership information to the following partners, Atrium Health, Piedmont, Emory Healthcare, Knight Foundation, and Warner Robins Rotary Club.
- The Strategic Initiatives Division's first site visit to Bloomberg Philanthropies grantees is scheduled for September 2025. Invitations to join the visit will be sent to school superintendents and healthcare professionals.
- On July 1, Dr. Tatrabian Jackson was transferred over to the Division of Strategic Initiatives. Dr. Jackson has worked at CGTC since November 2013. She has served in the role of Director for Satellite Operations for Baldwin, Crawford, Jones, and Monroe Counties. Most recently Dr. Jackson served as the Director for Advisement before joining the Strategic Initiatives division. We are excited to have her wealth of knowledge, passion, and enthusiasm within the department.

• We're also excited to announce that Tiana Wilson has joined the Office of Strategic Initiatives as Administrative Assistant to VP Dr. Scott. She joined the office on August 1. An estimated fifteen individuals participated in discussions, attended the event, and contributed support letters. Representatives from Robins Air Force Base, 21st Century Partnership, and the Museum of Aviation also demonstrated leadership and support for the event. Leadership from the Technical College System of Georgia, the Senior Leadership Academy, and Presidents of fellow technical colleges showed solidarity in their pursuit of excellence in serving our communities. Participation from Central Georgia Technical College team members included individuals from various departments and divisions. Their efforts helped deliver an exquisite and informative event that reinforced our commitment to advancing and positively transforming the lives of the communities we serve. In total, about sixty dedicated team members from the College attended to share this vision with the community.
