Statement of Need for Program in the Service Area: The need to replace carpenters who retire or leave the occupation for other reasons should result in a large number of openings. Carpenters with specialized or all-around skill will have better opportunities for steady work than carpenters who can perform only a few relatively simple, routine tasks.

Program Description: The Construction Career Launch Safety short certificate will provide students with the tool knowledge, tool safety, and workforce behavior training to begin entry-level positions in construction fields.

Program Description: The Welding Career Launch Blueprint Reading short certificate is designed to give students who have limited experience with welding the skills necessary to accurately read and implement welding blueprints to enable them to obtain entry-level employment in the welding field while they continue their education.

Apprenticeships Update

Mr. Pace and other AA team members are working on several apprenticeship opportunities in the program areas of accounting, electrical, machine operator.

Articulation Agreements

Dean Durham is currently working with Mercer University on articulation agreements for A.S. in Psychology and A.S. in Social Work.

TCSG is using CGTC's A.S. in Education to develop a state-wide articulation agreement.

Commercial Truck Driving Department

The CTDL program had an audit by the Federal Motor Carrier Safety Administration (FMCSA) on December 9, 2025. The evaluators were on site to review course content related to federal Entry Level Driver Training (ELDT) requirements, recordkeeping, program processes, and faculty qualifications. All areas were satisfactory and no findings were noted.

Computer & Business Technology Department

Team members met with State Farm and Geico representatives last week to reestablish the pathway to the workforce for CGTC's Call Center Insurance TCC. Faculty members are working with McGraw Hill Connect and Pearson to create a new module that allows students to simulate the Call Center environment using software similar to industry software. The group also discussed internship opportunities with one of State Farm's local offices.

The Cybersecurity Club attended the Middle Georgia Manufacturing Expo on September 30, 2025 at Robins AFB Museum of Aviation where club members connected with local industry leaders and explored the latest advancements in the field. The event was an excellent way of gaining insight into workforce needs and strengthen community partnerships in areas of Artificial Intelligence and Cybersecurity.

The Cybersecurity Club participated in the Putnam County Career Center Career Ready Expo on November 13, 2025. Sixty-three students stopped by CGTC's table and took the challenge of disassembling and reassembling a desktop computer.

Fifteen students from the Cybersecurity Club will be participating in the SkillsUSA 2026 competition scheduled for February 2026 in Atlanta, Georgia. This group will represent CGTC at the state level in several cybersecurity-related categories showcasing their skills, teamwork, and technical knowledge.

Ms. Farms, Program Chair for Computer Information Technology, served as a guest speaker on for the Adult Education GED students during their Career Day event on November 19, 2025. Ms. Farms shared information about the programs offered in the CIST Department.

Health Sciences Department

Surgical Technology faculty attended the AccredEx 2025 conference in Louisville Kentucky in November. Participation provided valuable insight into the latest accreditation trends, best practices for student assessment, and strategies for improving retention and overall program outcomes. The information obtained will directly support the Surgical Technology program's ongoing commitment to excellence and its preparation for the upcoming CAAHEP site visit in 2026.

AED Spotlight



The Workplace Literacy Program at Cutting Edge Landscaping, located in the scenic area of Middle Georgia, ran from September 20 to October 31, 2025, and successfully offered two evening classes specifically for Spanish-speaking employees. These engaging on-site sessions equipped workers with essential English-language skills for interpreting instructions, communicating effectively, understanding safety protocols, and achieving success in their roles.

The program's impact was evident: all 22 participating students not only engaged wholeheartedly but also passed their employer’s milestone test, signifying their progress and newfound confidence. CGTC Board of Directors Meeting

On October 24, 2025, Dr. Mark Scott participated in the “Power of Partnership” segment at the Technical College System of Georgia (TCSG) Leadership Conference in Savannah, Georgia. During the session, he outlined strategic initiatives’ focus on expanding healthcare access and generating job opportunities within our service delivery areas. He also introduced the proposed Regional STEM/Allied Health Academy, an initiative designed to strengthen workforce development and support early education pathways for future healthcare professionals.

On November 5, 2025, the Strategic Initiatives Division hosted a site visit to the Northwell School of Health Sciences (NSHS) in Queens, New York. The attendees included CEOs of Emory Healthcare, Piedmont, and Atrium Health, along with representatives from four out of the eleven school districts. The NSHS tour showcased innovative workforce development strategies, including the integration of advanced technology to simulate real-world healthcare scenarios. Their innovative learning techniques provided valuable insight into how students are being prepared for careers in the healthcare sector. The visit offered meaningful perspective and inspiration for the development of the Regional STEM/Allied Health Academy. Attendees engaged in productive dialogue around potential challenges and opportunities, and several strategic connections were established to support the initiative moving forward.



On November 12, 2025, a report was formally presented to Former Senator Sam Nunn for Bloomberg Philanthropies. The packet provided a comprehensive overview of the project’s progress, including revised floor plans that reflected the latest design adjustments. The report included an updated timeline outlining current milestones and projected completion dates. Additionally, a detailed review of the site visits that have been hosted along with the feedback and outcomes from those engagements. Within the report was a detailed summary of the milestone meetings that have taken place within the department, and the next steps planned for the Regional STEM/Allied Health Academy.

On November 14, 2025 a follow up meeting was held with the Houston County School District to discuss program requirements for the Regional STEM/Allied Health Academy. Information was exchanged regarding the programs to be offered. Sample completion plans were presented to develop a schedule that will allow students to meet both high school graduation requirements and CGTC program requirements simultaneously.

On November 17, 2025, a follow-up meeting was conducted with Kristy Beam from the Academy for Innovation in Medicine (AIM). During this session, Strategic Initiatives shared insights on the technology and school design observed during the recent site visit to NSHS. The discussion also outlined ongoing meetings with the local school district to ensure that students enroll in the appropriate high school courses to meet graduation requirements and complete their college coursework in a timely manner. These coordinated efforts are intended to support students in graduating with the credentials necessary to enter the workforce immediately upon completion of their studies.

On December 5, 2025, Strategic Initiatives conducted a site visit to NursesMC in Nashville, Tennessee. Attendees included the Commissioner from the TCSG, representatives from CGTC’s Administrative Services, Facilities and Health Sciences departments, as well as five school districts. The student-led tour showcased instructional methods and pathway design focusing on CNA and LPN. The team also participated in a teacher and student question-and-answer session, and established connections with NursesMC leadership.
