Purpose: The purpose of this Memorandum of Agreement ("MOA") is to define the relationship between CGTC and GCSU. This memorandum will assist CGTC and GCSU employees and students in making logical operational decisions based on previously decided issues, and is intended to prevent conflict between the parties which may arise out of simple misunderstandings or lack of knowledge of these decisions.

Terms:

- 1. The GCSU Library & Instructional Technology Center (LITC) and the CGTC Library to allow students of each institution access and utilize each institution's Library and borrow materials from alternate collections.
- 2. GCSU LITC and CGTC Library will:
 - a. Provide current I.D. cards, properly validated each semester, to all students with the understanding that these I.D. cards must be presented to the staff and the circulation counter of each respective library before any materials may be checked out.
 - b. Maintain strict observance of all borrowing policies and regulations of each respective library. Check out of library materials will be limited to three (3) items at a time.
 - c. Freeze any student's library record until all delinquent fines are paid. Each respective home institution of the borrowing student shall accept ultimate financial responsibility for any unpaid fees for lost or damaged materials.

In witness thereof, this agreement is entered into on 23 January 2013 and shall remain in force for an initial one year period after which it will automatically renew for one year periods unless otherwise modified. This Memorandum of Agreement may be amended at any time by mutual written agreement of both parties. It may also be cancelled at any time by either party upon not less than 180 calendar days written notice to the other party before beginning the next fiscal year.
